With reference to the captioned subject above, I am, by direction to inform that the University Grants Commission, New Delhi notification dated 23.06.2017 under annexure -IV and the Resolution for the item no.091 of the 304th Syndicate meeting held on 18.05.2018 reads as follows:

" Courses or Study Centres or Off Campuses and Territorial Jurisdiction of Universities :

- b) A University established or incorporated by or under a State Act shall operate only within the territorial jurisdiction allotted to its Act and in no case beyond the territory of the state of its location.
- d) No university, whether central, state, private or deemed, can offer its programmes through franchising arrangement with private coaching institutions even for the purpose of conducting through distance mode.

The resolution for the item no.091 of the 304th Syndicate meeting held on 18.05.2018.

" All the study centres of school of Distance Education, Bharathiar University situated outside the state of Tamilnadu shall be closed "
